5.2. Special hazards arising from the substance or mixture

Exposure hazards: Highly flammable. In combustion emits toxic fumes. Forms explosive air-vapour mixture. Vapour may travel considerable distance to source of ignition and flash back. In combustion emits toxic fumes of carbon dioxide / carbon monoxide. Hydrogen bromide (HBr). Hydrogen fluoride (HF).

5.3. Advice for fire-fighters

Advice for fire-fighters: Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.

6.1. Personal precautions, protective equipment and emergency procedures

Mark out the contaminated area with signs and prevent access to unauthorised personnel. Turn leaking containers leak-side up to prevent the escape of liquid. Eliminate all sources of ignition.
