6. ACCIDENTAL RELEASE MEASURES

Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). All equipment used when handling the product must be grounded. Stop leak if without risk. Ventilate the area. Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material.

Environmental precautions:

Keep away from living quarters. Prevent further leakage or spillage if safe to do so. Water runoff can cause environmental damage. Prevent entry into sewers, basements or confined areas; dike if needed.

7. HANDLING AND STORAGE

Precautions for safe handling:

Do NOT breath gas, fumes, vapor, or spray. Do not ingest. Avoid contact with skin and eyes. Keep away from heat and sources of ignition. Use explosion-proof equipment. Use only non-sparking hand tool when handling this product. Ground all equipment containing material. Take measures to prevent build up of electrostatic charge. Good general ventilation should be sufficient to control airborne levels. Keep container dry. Handle and open container with care. Wear suitable protective clothing, gloves and eye/face protection. When using do not eat, drink, or smoke. Keep away from sources of ignition.

Conditions for safe storage:

Store locked up. Keep containers tightly closed in a cool, well-ventilated place. Keep away from sources of ignition. Store and use away from heat, sparks, open flame, or any other ignition source. Keep away from incompatibles. Containers which are opened must be carefully resealed and kept upright to prevent leakage. Avoid prolonged storage periods. Store under inert gas (e.g. Argon). Hygroscopic material, store in a tightly sealed container.
