Description of Necessary First Aid Measures

Section 5. Fire Fighting Measures

General Hazards: Combustible liquid. Fire may produce irritating fumes and organic acid vapors.

Suitable Extinguishing Media: THE MOST EFFECTIVE FIRE EXTINGUISHING AGENT IS DRY CHEMICAL POWDER PRESSURIZED WITH NITROGEN. For small fires, vermiculite, sand, dry chemical or carbon dioxide (CO₂) may also be used. For large fires, large quantities of water (flooding) may be applied as a spray or a mist to control the fire and cool affected containers.

Unsuitable Extinguishing Media: Do not use water jet as an extinguisher as it may scatter and spread the fire.

Unusual Fire and Explosion Hazards: Vapor/air mixtures are explosive above flash point. Product runoff to sewer may create a fire or explosion hazard. Vapors/gases released under fire conditions are heavier than air and may spread long distances along the ground. Vapors may accumulate in low or confined areas or travel a considerable distance to an ignition source and flashback. Containers may explode when heated.

Product of Combustion: Carbon oxides (CO_x) and vanadium oxides. Irritating fumes and organic acid vapors may be generated during exposure to elevated temperatures or open flame.

Protection of Firefighters: Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. Avoid contact with skin or eyes. Avoid breathing dusts, aerosols, vapors and gases.

Eliminate all local and distant ignition sources. Move containers from fire area if process can be accomplished without risk to firefighters.

Section 5. Fire Fighting Measures

- Protection of Firefighters (cont.):** To reduce the possibility of explosion, use a water spray or fog to reduce direct vapors and to cool unopened containers. Do not cut, grind, drill or weld on or near product containers (even empty) of this product because an explosion may result.

Personal Precautions, Protective Equipment and Emergency Procedures

- For Non-Emergency Personnel:** No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid inhalation of vapors or mist. Provide adequate ventilation. Wear respiratory protection. Put on appropriate personal protective equipment.

Methods for Containment

Section 6. Accidental Release Measures

Large Spill:

Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with a dry, non-combustible absorbent material (e.g. sand, earth, vermiculite or diatomaceous earth) and place in dry, sealed container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilled product.

Section 7. Handling and Storage

Precautions:

Product is heat sensitive. Keep away from all sources of ignition – NO SMOKING. Keep container tightly sealed. Avoid contact with skin, eyes and clothing. Avoid the formation and inhalation of sprays, mists, vapors and gases. Do not ingest. Avoid prolonged exposure. Ensure adequate ventilation.

Protective Measures:

Protect against electrostatic charges. Use explosion-proof electrical/ventilating/lighting/handling equipment. Use only non-sparking tools and equipment. Put on appropriate personal protective equipment (see Section 8). Keep in the original container kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.

General Occupational Hygiene:

Engineering Controls:

Properly operating chemical fume hood designed for hazardous chemicals and having an average face velocity of at least 100 feet per minute. Provide an eyewash/shower station.

Environmental Exposure Controls:

Emissions from ventilation or work process equipment should be checked to ensure they comply with the requirements of environmental protection legislation. Skin Protection

Hand Protection:
